## EDITORIAL

Since our last issue, redevelopment work has finished at the site of the former Initial House at 150 Field End Road and new flats (known collectively as Portman House) have been built. Also in Field End Road, the site of the former Eastcote Garden Centre opposite the station has been redeveloped into flats over a small supermarket at ground-floor level.

Our post office has been relocated inside the shop at 145-147 Field End Road and a postbox is due to be erected outside on the pavement to replace the one at the old site.

Eastcote Underground station has finally gained 'real-time' train indicators in both directions which show the destinations (line only, London-bound) and times of the next three trains.

Our Annual General Meeting this year is being held on Wednesday May 13th at 7.30pm, when the guest speaker will be the Metropolitan Police Borough Commander, Chief Superintendent Nick Downing, Hillingdon's most senior police officer. We hope as many of you as possible will be able to come along to give him a grilling about your local policing worries. This is *your* opportunity to voice opinions, pose questions or offer suggestions and to consider whether you would like to get more involved with your local community. For the ERA to survive into the future, we need your input!

## WHERE DO YOUR SUBSCRIPTIONS GO?



Firstly I would like to thank you for, not only paying your subscription, but also taking time to read the newsletter.

The Eastcote Residents' Association is run by a committee of volunteers, some of whom are elected as officers to ensure the association is run in accordance with its constitution. To do this they have to hold nine monthly meetings and an AGM (all of which are open to all members to attend) and which incur hall hire charges and public liability insurance. We are very fortunate to have excellent support from our local councillors who regularly attend these meetings, so this is an opportunity for residents to voice their issues. Recently they have helped resolve the flooding in Cavendish Grounds, arranged for the path from the car park to the station to be improved and produced a clear policy on future roadside memorials.

The money raised through subscriptions is primarily used to communicate local issues to residents, by producing a twice-yearly newsletter and maintaining a website. These provide you, the resident, with much helpful information: useful telephone numbers, local events and, in this issue, what do in case of flooding. Committee members represent the ERA at other groups; some are free, such as HARA, the police SNT panel, residents' forum, conservation panel and RAF Northolt liaison, while others we subscribe to, for example, the Federation of Metropolitan Line Users' Committee, Community Voice (which covers local health issues) and the Campaign to Protect Rural England.

We also make donations on behalf of the residents, such as a wreath for Remembrance Day, and apply to the council for a grant to install festive lights in the High Street, paying the community contribution.

Over recent years we have had a high membership; consequently our income has covered our expenses with a little left over. This has been used to make donations to projects of benefit to the community, for example, the Eastcote House Gardens appeal, hedging at the war memorial, and the Ruislip, Northwood and Eastcote Local History Society to install a plaque commemorating the RAF Eastcote site, (formerly HMS Pembroke V), role as a codebreaking site during World War II.

## NOTICE BOARD

### THE ALLEY WAY LEADING FROM THE SHOPS TO THE STATION CAR PARK

The council have put the alley way on the list of areas a mobile CCTV unit will visit. A yellow warning sign has been put on the lamp post outside the alley way to inform people of this. The tree will be removed and the pavement repaired. The street cleaning team are now inspecting the area more regularly and the alley will be upgraded, to better light the area.

If anybody observes any criminal or anti-social behaviour in the alley way they should inform the police using the 101 telephone number.

### NEW POST BOX

A new post box is planned to be installed outside the Eastcote Post Office branch at 145-147 Field End Road. As a consequence, clearance needs to be obtained from the highway authority and the utility companies contacted to ensure that the proposed site does not interfere with existing pipes or cables, etc. This process can take a number of weeks to complete, but it is hoped that the new post box will be installed by mid-May.

## WHO ARE FOMLUC and HPTUA?

The Federation of Metropolitan Line Users Committee (FOMLUC), of which the Eastcote Residents' Association (ERA) is a member, was formed over 25 years ago and its members are the major residents' associations and user groups on the Metropolitan Line.

The suggestion for such a federation came from the then general manager of the Metropolitan Line who kept getting suggestions from those individual associations – and the requests, etc. often conflicted with each other and he felt that such a line should have 'one voice'. A committee was therefore formed of nominated representatives from those associations. The annual subscription from each association is currently £8.

FOMLUC has six meetings a year, in January, May and September. They are held with the senior management team of the Metropolitan Line at Baker Street at 5pm. In between these meetings, in March, July and November, other meetings of the FOMLUC committee are held at a venue in Harrow. In between all these meetings, matters of immediate concern are usually raised directly with the management team by phone or by email.

For my part, I have also chaired the Harrow Public Transport Users' Association (HPTUA) since 1977 (it was incorporated in 1963) and which holds five public meetings (and nine committee meetings) in Harrow each year. I also act as honorary advisor to Harrow Council on public transport.

## AVOIDING SCAMS AND ROGUE TRADERS

Generally, Hillingdon is a safe and pleasant borough to live in; unfortunately several residents have recently had encounters with a variety of scams and rogue traders. Some people have ended up losing thousands of pounds and have either had substandard work done or have nothing to show for it. Encounters with conmen can be extremely stressful and humiliating and it isn't just the old and vulnerable who have been taken in, although bungalows seem to be targeted frequently.

Although many people may feel they know what to avoid, it is as well to remember that conmen can work quickly and professionally at causing householders alarm, pressuring them into making quick decisions and seeming to be experts in their field. Many appear pleasant, helpful and willing to offer a good deal, especially if householders are parting with cash there and then. You should *always* get comparison quotes before any work is undertaken; *never* divulge your bank details to anyone over the phone or by email.

Elderly neighbours can be particularly trusting and gullible; we have been made aware of traders 'escorting' them to banks to withdraw cash for unnecessary work until their accounts have been drained.

## PLANNING APPLICATION REQUIREMENTS FOR SINGLE-STOREY REAR EXTENSIONS

The Article 4 Directive, enacted in September 2014 throughout the London Borough of Hillingdon, stated that single-storey rear extensions that extend beyond the rear wall of the original dwelling by more than four metres will once again require full planning applications (see our autumn newsletter).

Longstanding permitted development rights state that full plans are not required for such extensions that are up to three metres.



Therefore there is a ‘planning process gap’ for single-storey rear extensions of between three to four metres. These are dealt with as follows:

- As the owner, you do still have to notify the council, who will then only contact immediate neighbours
- As a neighbour, you have 21 days to object to the application – late objections cannot be considered
- If the council does not receive any objections within 21 days, the proposal will be approved as a permitted development
- If objections are received, the council has 20 days to assess the impact of the application and to determine it

## POLICE MATTERS

### **Safer Neighbourhoods teams**

The local Safer Neighbourhoods teams in the north of Hillingdon are different in size from how they were a few years ago so I want to take this opportunity to explain their current format. Each ward has a dedicated PC and PCSO. These two officers work a variety of shift and are dedicated to their ward. They are not abstracted from that ward unless there is a real emergency. Their primary role is to build rapport with the local community, attend events as well as identify crime prevention opportunities such as visiting all burglaries in their area and speaking to neighbours. Their names and faces are posted on our website [www.met.police.uk/saferneighbourhoods](http://www.met.police.uk/saferneighbourhoods)

A local sergeant has responsibility for managing two wards. Eleanor Charlston is the sergeant for Eastcote and East Ruislip (as well as for West Ruislip) and I encourage you to contact her, or me, if you have an issue that we can help to address. Each sergeant also has two to four further police constables, who are posted to report daily crimes and provide visibility across the whole of the north.

### **High visibility team**

Our new roving high visibility team has had a real impact in the north. Sergeant Liam Moore and his team have used a variety of tactics to catch those criminals who seem to think the north of Hillingdon is a soft touch. Tactics have included mobile patrols in uniform and plain clothes, foot and cycle patrols, and speed camera and number plate reading operations. Results so far have been very impressive: arrests for possessions with intent to supply drugs including cannabis and cocaine, seizures of mopeds and uninsured cars, and fixed penalty notices for speeding. This is just a snapshot of their work which is focused at those committing offences highlighted as being important to you, the local community.

### **Burglary**

Finally, I would like to emphasise the following piece of crime prevention advice: if you have multi-locking door handles on UPVC doors, lift the handle, lock it with the key and remove it. Remember: LIFT - LOCK - REMOVE. Put the key in a safe place out of sight in case of fire. The number of front door break-ins due to the door not being double-locked is astounding and is so easily preventable.

## SAFER NEIGHBOURHOOD

Safer Neighbourhood Boards (SNB) have been introduced across London in 2014 following a decision by the Mayor of London to hold Borough Police Command Units to account for performance and to give Londoners a greater voice in setting local policing priorities.

The board provides independent scrutiny, challenge, and strategic vision to ensure that the police collaborate and work together with other agencies successfully to co-ordinate and promote crime reduction in Hillingdon. Currently, the board membership consists of ten local individuals, including three lay members, two councillors and representatives from Neighbourhood Watch, Youth Council, Victim Support and Age UK.

The Hillingdon SNB is one element of a community-police engagement model that includes the 22 ward panels within the borough. These panels are intended to be representative of the local community and provide an opportunity to prioritise police response to address local problems.

A recent review by Scotland Yard into Safer Neighbourhood (local) policing is encouraging and illustrates the Met's commitment to the importance of local policing. Two of the recommendations, reducing abstractions and reinforcing the role of dedicated ward officers plus adjustments in neighbourhood officer shift patterns to increase policing visibility, will I am sure be welcomed in Eastcote. The SNB will be monitoring progress on the implementation of the above review to ensure that local policing meets the needs of local communities.

## Hillingdon Local Plan Part 2

This draft document will be on the agenda for the March Hillingdon Cabinet meeting. There will then follow another consultation on any changes made to the original draft. Going forward, the document will be examined by the Planning Inspectorate in December 2015/January 2016.

Eastcote Conservation Panel has suggested that Warrender Park/Highgrove Woods and Cavendish/Bessingby/Pine Gardens parks should become Metropolitan Open Land (MOL). These two areas are vital to Eastcote, giving residents a much welcome break in the urban area. These parks must be protected from any form of development. To have MOL designation gives the parks the protection of a presumption against development (see article from Friends of Pinn Meadows for more information on dual designation for the river Pinn corridor).

The works at Eastcote House Gardens (EHG) are overrunning; any events planned for May 2015 will not now take place. The Mayor of Hillingdon, Councillor Catherine Dann, will officially open the restored buildings on May 12th.

Although the FEHG events schedule has been on hold during the works, gardening has continued. Because of the delays to the buildings works, the walled garden will not be back to its full glory in time for the summer season. Behind the scenes work has been taken forward researching the history of EHG. A book, *Eastcote House & Gardens, the People and the Place*, by local author Andy P Weller, will be published in time for the summer picnic. Andy is now working on *Secret Eastcote*, looking in detail at the important part Eastcote played in World War II. FEHG are in the process of setting up an EHG archive, to be located in the gallery in the stables; more details will follow later.

## FRIENDS OF PINN MEADOWS

During the Local Plan Part 2 public consultation in September, objections to the proposed removal from Hillingdon's Green Chain of Pinn Meadows, Eastcote House Gardens and Manor Farm were submitted by the Friends of Pinn Meadows (FoPM), Eastcote Conservation Panel and Ruislip Residents' Association. Council officers will now be reporting back to the Hillingdon Cabinet in March with their proposed updates. The council had planned to change the designation of these Green Chain sites to Metropolitan Open Land (MOL); however, removing them completely from the Green Chain will weaken their protection, especially against any impact on the biodiversity and the natural habitats in and around the sites. Given that there are no adverse consequences of retaining the Green Chain designation, it is hoped that Hillingdon will follow the lead of other Councils such as Lewisham whose recently adopted Local Plan contained multiple sites with dual Green Chain *and* MOL designation.

Objections were also submitted by FoPM and residents' groups against the proposed weakening of the Green Chain policy. It is hoped that the council will retain the existing Green Chain policy wording which was adopted in Local Plan Part 1 in November 2012 and has been used effectively since then to protect our green spaces.

In other news, the work to restore the Kings College running track continues to progress and will provide an excellent amenity to the site to complement the recently installed outdoor fitness equipment. Work will also commence in the spring on a new project to build ditches and a network of ponds to alleviate the flood problems and increase the biodiversity around the meadows.

FoPM are also helping the Green Spaces team to prepare a Green Flag application for Pinn Meadows and, as part of this process, a new management plan for the site is being designed.

## THE HOSPITAL ON THE HILL A CENTURY OF CARING

A new and very interesting book with over 600 extraordinary pictures and stories recording 100 years of the orthopaedic hospital in Wiltshire Lane, Eastcote, has been published.

Jacque was the final matron of the hospital which commands its place in medical history as the second orthopaedic hospital in the country, starting life under the auspices of nuns in Clapham in 1907.

The Daughters of Charity of St Vincent de Paul Order developed a new site on Haste Hill in 1912, with the healthy countryside providing the original 12 ‘crippled boys’ with ‘fresh air, good food and rest’ and care by the sisters.

Jacque has plotted the changes at *The Hospital on the Hill* from the needy children with deformed bones and joints – resulting from TB, rickets, polio and osteomyelitis – to the recent years as a renowned hospital for adult orthopaedic surgery. The potted memories from ex-patients and staff, together with emotive pictures, tell a tale of yesteryear healthcare and compassion, the struggles for children growing up with disability, and the fun they managed to have.

Some boys given occupational training went on to become entrepreneurs in their field, like Bill Bowley, with local shoe shops in Northwood and Stanmore, and Terry Eager, a prominent bootmaker in the north. The annual fete days are well remembered, with notable supporters such as Dame Vera Lynn, Tommy Steele, Jimmy Edwards, Jessie Matthews and Bob Holness.



Many pioneering events occurred at St Vincent's, including one of the first mobile X-ray machines during World War 1 and injured soldiers during 1945 treated in penicillin trials. A nurse training school ran for nearly 50 years, boasting a 100 per cent pass rate under tutors Sister Clare and Irene Heywood Jones. Many of those orthopaedic nurses continue to practise in hospitals within the locality.

At the end of the hospital era, Jacquie fought for the site to become a beautiful purpose-built nursing home, which continues the St Vincent's tradition of loving professional care to a new group of Eastcote residents.
