High Speed Two (HS2) is the new high speed railway for Britain. As part of the railway's construction we're continuing with our preparatory works in the Hillingdon area. This is to ensure that the area is ready for us to start building the railway.

What is the tunnel boring machine power supply project?

A high capacity 33 kilovolt 20 mega volt amp power supply is required at West Ruislip for the Tunnel Boring Machines that will run between Ruislip and Old Oak Common creating the two HS2 tunnels.

Where is it going?

HS2 has recently contracted UK Power Networks to provide the power supply required to operate the Tunnel Boring Machines during the construction of HS2. Once the tunnelling is complete, the power supply will be used to power operational equipment within the tunnels.

The route has been formed in consultation with the London Borough of Hillingdon, the London Borough of Harrow and Transport for London to install the cables in residential roads to help minimise any impact on the local road network between North Harrow and West Ruislip.

On the next page there is an overview map that shows the route that is being currently considered. This is a proposal and some changes may still take place.

Harrow: Farm Avenue, Rayners Lane, Whittington Way, St Michael's Crescent, Cannon Lane, Connonbury Avenue, Rushdene Road

Hillingdon: Rushdene Road, either Deane Croft Road OR Abbotsbury Gardens, Field End Road, Meadow Way, Hawthorne Avenue, Elm Avenue, Lime Grove, Myrtle Avenue, The Uplands, Westholme Gardens, Manor Way, Midcroft, Ickenham Road.

This is a proposed route and some changes may take place. For example, the route was to go along a pedestrian footpath between Lime Grove and Hawthorne Avenue, but as this is a main pedestrian walkway the decision has been made to instead follow Elm Avenue. Another possible change is for an alternative route to go along Abbotsbury Gardens rather than Deane Croft Road. This option will be dependent on the trial hole data

When will work start?

In the next stage of the project, UK Power Networks need to excavate about 20 small trial holes at intervals along the proposed cable route. This will help them to understand the ground conditions and confirm where existing utilities are, as well as the most efficient path to take through the area. Each excavation will be about one square metre in size and the road surface will be returned to normal as quickly as possible. The work should not have any impact on your electricity supply.

The trial holes are currently due to take place late this summer. More details will be available on www.hs2inhillingdon.co.uk nearer the time.
